## CRUISE SAFETY RULES – SHIP KACZUSZKA

**APPLIES TO EVERY PASSENGER AND CREW MEMBERS ONBOARD**

**THIS SHIP**

### § 1

#### Responsibility of Shipowner and Crew Members

1. The shipowner fulfills his duties connected to the cruise as agreed.
2. The shipowner provides a technically efficient ship with appropriate and up-to-date documentation.
3. The crew of the ship servicing the cruise has adequate professional qualifications for their official positions.
4. The ship's crew works in accordance with seafaring ethics and good shipping practice.
5. Responsibility and all decisions related to the safety and course of the cruise are made by the ship's captain. Each Crew member is responsible for responding to security threats

### § 2

#### Prohibitions and liability of the Organizer and Passengers

1. During the cruise it is forbidden to:
  - a) Fail to comply with the recommendations and orders of the Crew.
  - b) Lean over the railings and sit on them.
  - c) Stand on tables, benches, chairs and any raised platforms.
  - d) Jump to touch or catch bridges while passing under them.
  - e) Stay in places not intended for Passengers.
  - f) Enter the wheelhouse and ON THE SHIP'S ROOF.**
  - g) Hit/damage the roof (there are solar panels on the roof, producing electricity during the cruise)
  - h) Open the entrance gates.
  - i) Destruct any of the ship's equipment.
  - j) Touch any electrical switches (including light switches).
  - k) Take actions that may directly or indirectly affect the safety and comfort of Passengers and Crew.
  - l) For passengers to bring their own alcohol and provisions by Passengers, except for separate arrangements with the Shipowner.**
  - m) Bring on board and consume drugs and other illegal substances.**
  - n) Litter, pollute and flood the deck.**
  - o) Enter the places marked with entry bans.

- p) Attempt to get off the ship without the Crew's consent.
  - q) Jump off the ship into the water and swim near the ship and at the harbor.
  - r) **Urinate in places not intended for this purpose (e.g. overboard).**
  - s) Stay on the ship after the end of the cruise.
  - t) Present behaviour inconsistent with the principles of good manners.
  - u) Show any form of aggression towards other Passengers, in particular towards the Crew and the Cruise Service.
  - v) **Use on board the ship and at the piers such objects as confetti, flares, firecrackers, lanterns, open flames.**
2. The Renting Person is the person who rented the ship
  3. The Organizer is the person who rented the ship or the person designated by the Renting Person.
  4. The Renting person is responsible for any material damage to the ship during the cruise. In the event of damage, he settles financially with the office of StatekWroclaw.pl. The price list of damages from "Appendix No. 1 to the Regulations - price list of damages" applies
  5. **The organizer is obliged to remain sober throughout the cruise, so that in an emergency situation they can act as a decision-maker on the part of the Renting Person.**
  6. Persons appointed by the Renting Person to operate the grill and catering must be registered with the boatswain and trained in safety.
  7. The cruise service on the part of the Renting Person (barbecue and catering service) is obliged to wear stickers and remain sober throughout the cruise.
  8. **The maximum capacity of the Kaczuszka ship, according to the shipping documents, is 55 people (including Passengers and staff from the Organizer / Renting Person), not including the Crew**
  9. **In accordance to the regulation of the Minister of the Environment (Journal of Laws of 2007, No. 120, item 826), it is forbidden to play loud music and generate noise. On the ship, the music should be turned down to such a level that it does not break the rules of the above regulation. In addition to music, all other sources of noise should also be adapted to the above-mentioned conditions. (e.g. shouting)**
  10. **In the case of a situation indicating the need to cover the ZAiKS fee, this obligation rests with the Organiser.**
  11. The time to leave the ship after the end of the cruise is 10 minutes (except for separate arrangements). After this time, another fee is added.

### § 3

#### **Unscheduled termination of the cruise**

1. The Renting Person / Organizer obliges the Passengers of the cruise to strictly follow the instructions of the Crew.
2. The captain of the ship may decide to immediately terminate the cruise in the event of:
  - to take rescue action for the Passenger / Passengers / other persons
  - serious failure to follow the Crew's instructions by Passengers, affecting the safety and proper course of the cruise
  - deliberate jumping overboard by a Passenger/Passengers
  - fights among the Passengers, both among themselves and with members of the Crew
  - punishable threats against the members of the Crew or other Passengers
  - **PASSENGER ENTRY ON THE ROOF OF THE SHIP**
  - **the state of intoxication of Passengers affecting the safety of the cruise (it is allowed to remove Passengers in the above-mentioned state from the ship at the nearest possible marina and continue the cruise)**

- in any other possible case, when it is necessary and the only possible solution that will ensure the safety of navigation and Passengers and Crew

In the event of an unplanned termination of the cruise due to the above-mentioned reasons, there is no refund of the cost of the cruise, additionally, if necessary, the appropriate security services are called to the ship.

#### § 4

#### Possibility of unscheduled prolonging of the cruise

1. The crew and the shipowner have the right to the unscheduled prolonging of the cruise and to refuse to prolong the cruise without giving reasons.
2. The Captain decides indisputably on the possibility of prolonging the cruise after consultations with the Crew
3. The cruise will not be prolonged if the condition of the Passengers (e.g. intoxication) threatens the safety and may cause a lack of proper behaviour or there is the occurrence of any threats.
